Four Senses of the Public Law-Private Law Distinction

2 Public Versus Private Complainants According to a second distinction between public and private law, "public law" causes of action are those that are usually brought by governmental ("public") authorities "Private law" actions are those usually brought by the private individual who was harmed (or her representative or heirs)'
